SYMBI 5th call summary

The aim of the INTERREG EUROPE 5th call is to provide new opportunities to approved projects, in order to exchange experiences on the way the COVID-19 crisis impacts the issue they address and to further improve their regional development policies to better face the current challenges.

The pandemic has caused major disruptions in SYMBI partners' efforts to transition towards a circular economy model, since governments and industries are most concerned with responding to immediate emergencies. Securing by any means the production of necessities and the operation of supply chains, however, has come at the expense of sustainability and circularity.

At the same time, the pandemic has exacerbated the ineffectiveness of linear territorial economic models in times of crisis, raising concerns not only for recovery but also for future resilience. Considering that industrial waste, energy demand, and CO2 emissions skyrocket after major crises, there is a pressing need to resume and further advance the circular transformation in the participating SYMBI territories, in light of policy gaps uncovered by COVID-19.

Communication tasks

As leader of the SYMBI activities A3.1 and A3.2 "3.1-Stakeholder dialogues & dissemination", the Pannon Novum West-Transdanubian Regional Innovation Nonprofit LTD (PA-NOV) will fine-tune, prepare and deliver a communication plan that defines the communication strategy and actions to be carried out throughout the duration of the SYMBI additional activities, foreseen to take place within the 5th call. The main aim of the communication plan is to ensure the diffusion of results and the participation of stakeholders and 3rd parties in project activities, by extending and updating the communication plan already in developed in for the initial project duration.

This activity also foresees the regular and on-going updates of the SYMBI project website and social media pages, in line with the communication plan requirements, but also ensuring that stakeholders are kept updated on activity progress.

Finally, two electronic newsletters will be developed and shared with the partnership by PA-NOV, at the end of each semester aiming include major project activities and news.
